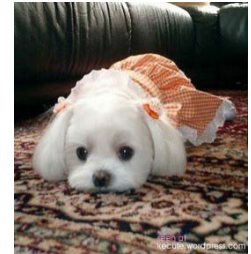

Release of Liability

I understand that all directions are final and that the Norco Fair Committee reserves the right to refuse participation in the Norco Fair Pet Parade to anyone. This agreement is binding upon my executors, heirs and assigns. I expressly wave any rights I may have under California Civil Code 1542, which states: "A general release does not extend to claims which the creditor does not know, or suspect exists in his/her favor at the time of executing the release, which if known by him/her might have materially affected his/her settlement with the debtor". I agree that I will indemnify and hold harmless. I acknowledge that I have read this Release of Liability and know and understand its contents.
