The Norco Community Fair Home Brew Competition is here again. This will be a non-sanctioned competition. No need to be a member of any club or organization to enter. Just get an honest opinion of your home brew. All entries will consist of two bottles (minimum twelve ounces) and each entry is \$5.00. Each bottle needs to have a bottle id form, rubber banded around it. Please do not use any tape or glue on the bottles; and make sure that there are no identifying marks on the bottles. Entry forms and bottle ID forms are below. All entries must be dropped off at Sports Nut Pizza 1820 Hamner Ave Norco by Saturday, August 17th no later than 9PM; or MoreBeer in Riverside by 5PM on August 17th.

The competition judging will be held Sunday, August 25th at Sports Nut Pizza 1820 Hamner Ave Norco. **In order for a successful competition, we are always looking for judges and people to help with the competition. It is not necessary for someone wanting to help to be a BJCP sanctioned judge. If you are interested in helping, please contact Ty Mitchel at 951-736-2015.** All beers will be judged; and ribbons will be awarded for first, second and third place in all categories. There will be awards for Best of Show, first through sixth. All decisions of the judges are final. All judges' sheets and ribbons will be on display at the fair from August 30th thru September 2nd.
